1. CALL TO ORDER/ROLL CALL

2. APPROVAL OF AGENDA/CONFLICTS OF INTEREST

The agenda for the July 29, 2020 meeting was unanimously approved with the addition of review of new requested lake rules and discussion of swinging rope at the lake.

The Board Members present were surveyed for conflicts of interest and none were found.

3. APPROVAL OF PREVIOUS MINUTES

The Minutes for the June 8, 2020 minutes were unanimously approved.

4. INSTALLATION OF NEW BOARD MEMBERS

President Paulette Church thanked outgoing members Susan Morton and Joan Heil for their service. Paulette indicated that new members Elaine Ehlers and James Glover will each serve 3-year terms.

There was some discussion of new roles for the Board Members this year with the following decision:

- James Glover At Large

There was quite a bit of discussion about how to handle the Secretary's role since much is expected of that position. Decisions made include:

- Elaine Ehlers board minutes/agenda
- James Glover annual meeting planning (with Joan Heil continuing in her role as Social Chairman to help with this)

A motion was made and seconded to approve the new Board of Directors and their roles.

4. NEW BUSINESS

New Lake Rules – Barb Belanger

Barb Belanger presented 3 new lake rules that the Committee would like the Board to approve:

- 1. Implement a barbless hooks policy
- 2. Designate specific fishing areas and limits
- 3. No motors of any type on the lake

The most discussion centered around #3, no motors of any type on the lake. Those present agreed that there is too much risk and danger to have motors on the lake due to swimmers, children, dogs, etc. Paulette indicated that 30 days after the new rules are posted to the membership, the Board can approve at the following meeting after reviewing feedback/comments

There was a motion and a second to approve the changes to the lake rules pending member feedback and a final action by the Board.

Removal of Lake Swing – Paulette Church

There was some discussion about a rope swing that residents had put on a tree on the lake and the potential danger and liability for the ranch for allowing such a rope swing. Apparently, the rope swing gets taken down and then someone will put it back up again. Some present complained about the Board regulating residents' behavior. Others strongly believe it is a safety issue with potential liability.

RESIDENTS USE OF SOLAR PANELS

There was a brief discussion about a resident's use of solar panels and Paulette Church indicated that this will be communicated in full at the August Board meeting. Paulette emphasized that, as a Board, we need to support our committees. The resident has a deadline of August 15, 2020 to provide requested documents and fines are being considered.

5. NEXT MEETING

There was some discussion about date/time for future meetings and all agreed that the 4th Wednesday of the month at 6:00 p.m. will work best. The next meeting will be at 6:00 p.m. on August 26, 2020 (Wednesday) for a regular Board meeting and will be another ZOOM meeting (unless things change). All members are welcome to attend.

The Board, by motion duly made, seconded, and unanimously approved, adjourned the meeting at 7:06 p.m.
