# **Beautification** -

**Common Property** – Phil Boroff is stepping down as Chair at the end of September. If you would be willing to take on leadership of one of the main tasks of this committee please let him know. Main tasks include weed management, supervision of Firewise work team, planning of Firewise projects, oversite of common property facilities (tennis court, orchard, garden, mailbox area, pump house areas, picnic area, and dumpster area), general supervision of all common property and review of building projects that impact common areas.

#### Dam –

**Fire Wise Ambassador** – We have continued working on the east side of Falls Creek Main north of Aspen. Logs are being pulled out and slash is being chipped in place. This area was very dense and threatened our roads in case of a fire, so this has been a priority area. Crew plans to complete this work and remove logs before Main is chip sealed.

Any wood down or left along roads that is not marked in red for Timber Age may be harvested by residents.

We have many cords of firewood ready if residents would like to have cut and split firewood delivered to their home. The lower cost this year is \$150 to FCR and \$100 to crew for pine, \$200 to FCR and \$100 to crew for mixed wood, and \$250 to FCR and \$100 to crew for oak. Please do not bring other firewood into FCR due to pests and disease it may bring with it.

**Front Entrance** – Plans have been resubmitted to Mark Smith for a construction drawing. Mark Smith is getting a bid for the electric work.

Horses –

**Lake –** Mark had sand delivered and he spread it out on the beaches. It looks and feels great. There are lots of healthy fish in the lake. Many residents have been out catching them.

Jenny Holmen has let us know that she will be stepping down as lake co-chair at the end of this season. She has been a pleasure to work with and to learn from. We will certainly miss her organized leadership style along with her willingness and ability to get work done. Thank you for your service to our committee, Jenny!

**Post-Wildfire Recovery Report** – Still waiting for funding for the proposed culvert installation and hardening at Dyke Canyon crossing from SGM. They plan to finish the project soon.

**Roads** – Roads are in good shape from the Spring rebuild and little rain since then. Lots happening this month. The vote on chip sealing Falls Creek Main from the entrance to Oakcrest was successful. 80+ votes in favor of the chip seal. For those of you who participated in the vote, regardless of how you voted, thank you for voting. Here is the schedule for the upcoming work:

Beginning August 15, we will be improving barrow ditches, removing windrows, filling potholes, crowning places in the road where water has historically collected, cleaning culverts and generally prepping the road for chip seal.

Beginning August 28, we will be working with Western Chipseal building speed humps, compacting the repaired road surface, sweeping off loose gravel and stockpiling materials. We will be storing road base for the project at the parking area across from the mailboxes. This area should be avoided between **August 28 and September 1** as it will have materials and equipment on it most of the time. You will be able to get mail, but please don't park across from the mailboxes.

The application of the chip seal is scheduled for August 29, 30 and 31. Final inspection and cleanup is scheduled for Friday September 1. The road should be ready and fully open for the start of Labor Day weekend.

Falls Creek Main will remain open during the entire project. While prepping and chip sealing is going on, please cooperate with the folks doing traffic control. Also, be aware that Ray and the road committee folks and volunteers will be doing a lot of work on Main prior to the end of this month. Please keep speeds to a minimum when passing by the construction equipment and crews.

Thanks to all our residents who participated in the voting and resulting project. The Roads Committee will do all it can to make this a successful project and to care for our roads in the future.

**Utilities –** No update for well-drilling date yet. Bid for new mixers at \$37,700 (\$37,000 budgeted)
