## Treasurer's Report

We received another \$16,821.40 Wildfire Adaptive grant payment in November, for work completed last fiscal year. A big thanks to Paulette for her continued work on applying for these funds to help offset our mitigation costs.

The Ranch House renovation is complete, with the total renovation cost of approximately \$28,000. The renovations were more extensive than originally thought, as issues arose that needed to be addressed. We received the final bill from the electrician for wiring from the firehouse to the front gate. The total came in at \$3970, which was well below the estimate. A big thank-you to Joe for all of his extensive work on this project and the Ranch House renovation. We also transferred the firehouse electric bill from the Fire Dept to our LPEA invoice. The first invoice was \$44.00. This was the most affordable way to get power to the entrance for lighting and the future electric gate.

The grader maintenance came in at \$17,500 (\$2,500 under original estimate) and will be charged to the capital expenditures account in December.

All of the monthly water base fees of \$10,100 per month have been transferred from the Operating Account into the Water Capital Account (through November).

# Committee Reports

## **Common Property**

Mark Smith spent multiple days working with the Fire Department in regards to burning the piles on common property. We are coordinated with San Juan National Forest on the burning of the piles below Oakcrest. The plan is to burn our piles at the same time as the Forest Service burns the piles south of our entrance and north of our property east of High Meadows. The Forest Service plan is to do this during a heavy snow storm, whenever that comes. Heavy snow should help to clean the smoke out of the air as it falls and lessen the effects of the burn. We are following their lead on this process.

## **FireWise**

I submitted our Annual Report for the Southwest Colorado Collaborative Forest Landscape Restoration Project and La Plata County so our work will be mapped and continue to lower our wildfire risk rating. Some of our lots are now rated Low Risk, which is wonderful!

Remember that extra large loads of split firewood (mostly pine) are available for just \$200, paid by check to Falls Creek Ranch, and \$100 paid in cash or Venmo to Kern for loading, delivering, and dumping it out the trailer on your lot. If you want it stacked, you pay \$35 per hour for each of the two staff members – still a great deal. Contact Paulette to schedule.

We were able to burn a few small piles of slash near the orchard and were careful to work when the wind blew the smoke away from the chickens and bees. Mark Smith is working with Durango Fire Protection District to update our burn permit while Scott Silveira works with the Colorado Department of Public Health and Environment on the air curtain burner permit. Many regulations changed last year and this year so procedures have changed and there are lag times as staff is trained.

We will know next month if we received the two grants we applied for, including a disc mower for along the roads and in meadows and for focused mitigation work along Falls Creek Main.

Please do not take any materials to the air curtain area, the slash yard. Also, we will let you know when we can burn again and when we can pick up bags and chip slash along the roads in the spring.

Christmas trees are still available at \$2 per foot and branches from Charlie Brown trees are free. Call Paulette to schedule.

I did install Turf Defenders that will help save our dirt roads from the plow blade. Mark and I have been working on getting rid of all the slash and pine needle bags down at the burn area.
